ICEGATE has rolled out a functionality for Parent Custodians to add GSTIN against their Custodian Code and both ICEGATE ID & GSTIN for each of their Child Custodians. The details can be added post login on ICEGATE Portal. Considering the need of catering the issues being faced by trade in day-to-day data exchange, this functionality has been developed.

The option of adding the details is available post login on the ICEGATE Portal.
